## **BEE Ownership Certificate for ARC Financial Services Investments (Pty) Ltd**

Further to the report ELC10398, we can confirm that Economic Interest to which BDG's, EOS, BBOS and Co-op's are entitled of 40.01% are broken down as follows:-

- Black People living in Rural areas 0.49%
